1. **Initial Consultation Session** \$ 497
2. **Consultation Plans** – Paid in advance, charged at rate per hour pro-rata (for time used):

  - Plan B: Buy 10 Hours Professional Counselling Consultations @ \$240 per hr \$ 2,400
  - Plan C: Buy 15 Hours Professional Counselling Consultations @ \$198 per hr \$ 2,970
3. **Home visits** – Charged at fee per visit (additional to the fee in 1 or 2 above) \$ 120

## PAYMENT TERMS

- All Consultation and Marriagology.com Fees are to be pre-paid in advance of the consultation by:

Consultations thereafter are only available via one of the two prepaid Consultation Plans where fees are charged at rate per hour pro-rata for hours used. - Gosling International **DOES NOT** allow time-payment of your account, e.g., 30 days credit. Please **DO NOT** ask for time-payment as a negative response may offend.
- Charges to your credit card will be in AUD\$. Gosling International's payment service providers, PayPal and eWay/NAB will provide you with an electronic receipt for your payment via email.
- Gosling International will post you an invoice/receipt on completion of the consultation fee/service.
- Pre-paid Consultation Plans may be used for individual, joint, or group appointments, but are not transferable to other parties. **All plans and memberships expire after 1-year from date of purchase.** Once a pre-paid Consultation Plan has been completed, a new pre-paid Consultation Plan should be purchased for ongoing consultations.
